Outdoor Training Curriculum

AIM

The main aim of Outdoor training is to teach the recruits to wear an impressive turn out, to build and maintain high sense of discipline and confidence and to inculcate the sense of pride and belonging to police force.

They learn about the basics of obedience, regards and discipline by learning the saluting to the seniors. The purpose of weapon training is to teach trainees the handling of weapons for all types of duties and also to make them proficient in firing practice. The aim of the Crowd/Mob control training is to teach the trainees the use of minimum force with maximum effect in order to effectively dealing the rioters or law breakers. Mob control training is very essential to handle agitations, demonstrations, fairs/melas and other lawful and unlawful assemblies.

The purpose of Field Craft & Tactics training is to teach the trainees the way to change and adopt the ground situations (camouflage)in order to meet the challenge of hostiles. The aim of this training is to teach the measure/use of techniques to observe, control and capture/immobile the hostiles. The training regarding MAP reading, use of Compass and GPS (Global Positioning System) serves the purpose of move with the help of map, to teach night navigation and night march in unknown areas.

The aim of VIP Security training is to protect the V.I.P. from hostiles against sabotage, subversion and assassination. The emphasis will be on making them proficient in driving so that they can do effective patrolling in the village, town and city areas in order to prevent and detect the crime and collect the information.

The purpose of training in the subject of Traffic Control is to teach the trainees as to how to regulate the general traffic in towns and on other busy roads in order to ensure smooth conduct of the traffic and to prevent the accidents. Another field of the training is to teach the way to recruits as to how to take the prisoners from the jail to court and back safely. The aim of the UAC is to make the trainees alert, tough and proficient for offence & defence in order to combat the hostiles without arms. The purpose of training in first aid is to provide primary assistance to the injured on the spot before the availability of regular medical facility.
